**A RESOLUTION ESTABLISHING FEES FOR SERVICES PROVIDED BY THE CITY  
OF MT. ANGEL**

**WHEREAS**, the City Council has repealed its ambulance franchise with Woodburn Ambulance in favor of an ambulance service licensing process; and

**WHEREAS**, the Council is charged with setting the ambulance licensing fee by resolution;

**NOW, THEREFORE BE IT RESOLVED:**

**SECTION 1.** The fee schedule attached as Exhibit A is adopted.

**SECTION 2.** The fees established by Exhibit A of this resolution take precedence over the same fees which were previously adopted by resolution or administrative policy.

**SECTION 3.** This resolution shall be effective upon adoption.


