

**CITY OF MT. ANGEL
RESOLUTION NO. 1439**

A RESOLUTION ELECTING TO COSPONSOR AN AMENDMENT TO THE SILVERTON – MT. ANGEL ENTERPRISE ZONE TO INCLUDE ADDITIONAL LAND IN THE CITY OF MT. ANGEL.

WHEREAS, In 2013, the City of Silverton successfully applied for an enterprise zone, which was designated as the Silverton Enterprise Zone by the Director of Business Oregon on May 3, 2013. The designation of an enterprise zone does not grant or imply permission to develop land within the Zone without complying with all prevailing zoning, regulatory and permitting processes and restrictions of any and all local jurisdictions; nor does it indicate any public intent to modify those processes or restrictions, unless otherwise in agreement with applicable comprehensive land use plans; and

WHEREAS, in August 2013, the City of Silverton successfully expanded the enterprise zone to portion of Mt Angel and re-named the zone as the Silverton – Mt Angel Enterprise Zone and included the City of Mt. Angel as a cosponsor; and

WHEREAS, this Enterprise Zone and the three-to-five-year property tax exemption that it offers new investments in plant and equipment by eligible business firms are critical elements of local efforts to increase employment opportunities to raise local incomes, to attract investments by new and existing businesses and to secure and diversify the local economic base; and

WHEREAS, The City of Mt Angel is requesting to expand the Silverton – Mt Angel Enterprise Zone to include additional land in Mt Angel.

WHEREAS, The City of Mt. Angel is currently a sponsoring government of the Silverton-Mt Angel Enterprise Zone; this proposed amendment to the zone boundary includes additional areas within the jurisdiction of the City of Mt. Angel. Officials of the City of Silverton are agreed in requesting an amendment in the boundary of the Silverton-Mt Angel Enterprise Zone that would add the additional areas in Mt. Angel indicated in the attached map and such that the amended Enterprise Zone would be configured according to that map and attached description. Notification was sent to all affected taxing districts.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF MT. ANGEL:

Section 1: That the Cities of Silverton and Mt Angel request an addition to the boundary of the Silverton – Mt Angel Enterprise Zone as shown in the attached map and legal description (Exhibits A & B)

Section 2: That Jason Gottgetreu, on behalf of the City of Silverton and Nick Harville, on behalf of the City of Mt. Angel, are hereby authorized to prepare and submit technical memoranda to the Business Oregon, along with this resolution and other necessary documents, verifying that the requested boundary change to the Silverton - Mt. Angel Enterprise Zone complies with the requirements of ORS 285C.115, so that the request herein may be approved by order of the department's Director.

Section 3. This resolution shall become effective immediately upon adoption.
